What's Happening at the Inn at Arrowhead?

"More than just a renovation," says Pat and Jess Amie, "it is for the community." Since purchasing the Inn in August 2013, Pat, Jess and Zach have been committed to providing the community with an enjoyable place that will not only function as an inn, restaurant, and bar but also as the heart of the community, a place to relax and enjoy. Yes, they have good food and drink, and the occasional live music, but there is more to it than that.



After spending the past year getting to know people on the mountain, and looking forward to meeting those they haven't, they have come to love all that this mountain community is. This winter they enjoyed snowmobiling and seeing what winter had to offer and are looking forward to the summer months and the grand re-opening as the weather turns warmer.

The Inn closed at the beginning of April to begin major renovations to improve safety and comfort and to allow more people to be served.

They were on a timeline and the more they did the more they realized they needed and wanted to do. But how to accomplish this in the time they had? There were set backs initially. As they got into tearing things apart it seemed everything they touched had issues. They found major water damage to the foundation and under side of the building. They tore out the sub floor and replaced everything on the foundation walls up. They were also committed to it being a community project, built by those in the community as much as possible. But would this be possible in the time allotted?

FORESTRY MESSAGE BY BILL CONWAY

Summer is here and it is again time to think about defensible space and mitigation on your property. Many lots have made good progress and a large number are in great shape. With the increased number of large fires in Colorado, there was more interest by insurance companies in reviewing individual lots last year and that trend is expected to continue.

Removal of green standing trees over 2" in diameter requires a permit from the Forest Manager. The reason for that regulation is to get the Forest Manager involved in helping you manage the trees on your property. That can range from a complete mitigation and defensible space plan to an individual tree that could be a hazard to an improvement or vehicle. This is an interactive process between the lot owner and the Forest Manager and is tailored to the conditions on each lot and will include a review of any insects or diseases that are affecting your trees.

Any forest debris removed from lots must be taken to the Forest Refuse Site (commonly called the No Stump Dump) located in the fenced area along the Alpine Road about one mile above Arrowhead. The site is burned in the winter and has to be checked for hold over fire in the spring by the fire department. The front end loader is also used at the site to do some cleanup before being opened for the summer. Check with Courtesy Patrol to see if the site is open and for the combination to the lock (same combination as last several years). No stumps of any size are allowed (requirement of State burning permit).

Logs over 6" diameter must be placed in separate signed area
Forest debris only – No construction materials

By the time you receive this newsletter you should have picked up the MCH beetle repellent packets that were ordered last fall. 2000 MCH packets will be put up on community property and 8800 on private lots. These packets are effective on both Douglas fir and spruce beetles. The Douglas fir beetle is expected to continue to be a problem in small patches. The spruce beetle that is building up on nearby Forest Service and BLM land has the potential to increase to epidemic levels that could kill all of the spruce in this area. The spruce beetle trapping program is being greatly expanded this year at Arrowhead. The objectives are to both reduce the beetle populations and to monitor the level of infestation. It will be about 5 years before we know if these efforts are successful.

Another part of this process is the timely removal of beetle infected trees and that process will continue on community property and by consultation with owners on their lots. Douglas fir and spruce trees that are turning brown or red or are showing signs of increased wood pecker activity should be reported to the Forest Manager immediately.

Because the Forest Service has such a large area, MCH packets and trapping are not effective options on their land. They are

attempting to deal with the spruce beetle problem by removing infected trees. That is part of the reason for the Forest Service timber sales that were being hauled down the Alpine during this last winter. Conditions to regulate that winter haul were negotiated between Arrowhead, Forest Service, and the timber sale purchaser (Montrose Forest Products) and made a part of the timber sale contract. Some of the road maintenance requirements from the winter haul will be completed when road moisture conditions permit. The cooperation between the community and the loggers was tremendous and I want to thank everyone for their cooperation.

The Long Draw Timber Sale was not completed before the spring thaw started, so more haul from that sale can be expected. As the spruce beetle continues to spread, additional sales will be sold over the next several years. These sales will be hauled down the Alpine Road. The Alpine is a Forest Service road but the maintenance is done under several different agreements. Snow plowing is done by Arrowhead under a special use agreement with the Forest Service since 1983. Blading, dust abatement and some other maintenance activities are done by Gunnison County with part of the funding provided by the Forest Service. Arrowhead also coordinates with Gunnison County and does spot blading before the full blading operation occurs. Surface rock is added to the road using funds collected from Forest Service timber sales. When timber sales are hauled down the road, the timber purchaser has contract requirements for road maintenance. Coordination between all these parties occurs throughout the year in order to maintain the Alpine. Even with all these efforts there are certain times, especially in the spring, when the freeze, thaw and moisture conditions make it impossible to maintain the entire road to desired levels.



FIRE CHIEF'S REPORT

We'd like to welcome back all our summer residents. It's always nice to see our friends we've missed over the winter.

It's been a good winter in the Arrowhead area for snow pack. We're starting the summer off right. With conditions like these, it's easy to be complacent with campfires. Let's not let the complacency bite us. Clean up your fire pits and have the courtesy patrol inspect and approve them for a fire permit.

The 4th of July Picnic (being held on July 5th) is right around the corner. Money raised from the picnic will go towards medical equipment and our evacuation exercise on July 26th. Please contact Bille Ellis at 862-8220 or Kathy Koeltzow at 862-8243 if you'd like to volunteer for the picnic. There are lots of positions needing to be filled.

Speaking of volunteers, we can always use extra fire fighters. No experience necessary. We will do the training. Being a member of the fire department is a great way to meet your neighbors and help your community at the same time.

Our evacuation exercise will be held the morning of July 26. The objective of the exercise is to contact every resident on the mountain. At approximately 10 am Gunnison County will call a code red (formerly known as reverse 911) to those Arrowhead residents with land lines, and those who have registered their cell phones with the code red system. To register your cell numbers please follow the directions from the following link: <https://public.coderedweb.com/CNE/BF7ED953CC69> We will also send out teams to evacuate everyone face to face handing out a flyer. As we are attempting to evacuate everyone in a timely manner, we hope that if you have any questions you will save them for the personnel at the evacuation site.

You will be asked to evacuate to the winter parking lot. Please keep in mind this exercise is completely voluntary. If you wish to stay home, that is perfectly all right. For those of you who wish to participate, the fire department's auxiliary would like to thank you by providing lunch and some good information concerning an evacuation when it becomes necessary. Please remember to bring chairs so you can eat your lunch in semi-comfort. If you do not wish to have any fire fighters on your property, please call me at 862-8277 and let me know. If for some reason you were not contacted by code red and face to face, we wish to know about it. Arrowhead has never practiced an evacuation and we expect to learn from this exercise. There will be multiple agencies participating in this scenario.

It is good to have the roads open, but it is still quite muddy. There have been a couple bears sighted and I saw deer close to my house today, which means the animals, at least, think summer is coming. There are also 3 garages, 1 shed and a deck remodel that have been approved for this summer.

This summer we will be having the evacuation practice. There are many lots with houses, and RV's that do not have

address signs. Please take time this summer to put up an address sign at the filing road to identify your property. If there are multiple drives, a second sign should indicate which drive goes to your lot. This is important to help firemen and 1st responders find you or someone else in case of emergency. The sign should be 1 foot by 2 feet or less, or 19" in diameter. The sign should follow the description in the Regulations.

HEALTH on the MOUNTAIN

One day we have 10 inches of snow, a week later, spring and a week later it is summer. Typical for Arrowhead. It is time for school to be out and people will be coming to Arrowhead for our wonderful, cool summer weather.

There are several things to remember when coming to the Arrowhead altitude. We are about 9400 feet. We are closer to the sun, so be careful of sun exposure. Exposure before 10:00am and after 2:00pm is better if you can determine your time out. Be sure and use a high SPF sunscreen on all exposed skin. Since humidity here is low, you will need lotion for dry skin. Sunglasses will help with glare and protect your eyes. Contact lenses can also be troublesome in this high dry climate. High permeability lenses should be used and don't sleep in them.

As many as 75 % of people will have symptoms of Acute Mountain Sickness (AMS) at 10,000 ft. or more. Mild symptoms occur within 12-24 hours. These include headache, dizziness, fatigue, shortness of breath, loss of appetite, nausea, and disturbed sleep. These symptoms are generally mild and will usually go away in a 2-4 days. The atmosphere contains about 21% oxygen at sea level and the barometric pressure is 760mmHg. At altitude the percent of oxygen is still 21%, but because the pressure (480 mmHg) is less, the molecules are further apart. Your breathing must increase to get enough oxygen. Short term compensation is hyperventilation and increased pulse rate along with elevated blood pressure. Long term compensation occurs over several months. This includes the body producing more red blood cells to carry oxygen.

The best treatment for AMS is to go to a lower altitude for a day and then gradually increase the altitude. People who fly from sea level to Denver and are on the slopes by afternoon are more likely to be subjected to AMS. It would be better to stay in Denver overnight before hitting the slopes, but vacation time usually doesn't allow for that. Other treatment is to maintain good hydration, avoid alcohol and coffee, and stay well fed. There are some medications that can be used for AMS. If you have an altitude problem, you might discuss this with your physician before traveling to high altitude.

The two most serious problems are High Altitude Cerebral Edema and High Altitude Pulmonary

Edema. This is caused by fluid leakage into the brain or lungs. Since the leakage of fluid may be slow, it may be several days before symptoms occur. If you are in Arrowhead, call **911**; an ambulance will be sent from Gunnison and the Arrowhead first responders will be sent. A helicopter evacuation is available if needed.




Yes, this is more than a renovation. It has been a project by the community, for the community.
