For RV Lot owners: One RV may be on the lot for the duration of the camping season. A second (2nd) occupied or unoccupied RV is allowed on a lot for a maximum of 14 days per named calendar month during the camping season.

Emergency Vehicles: Placement of the additional RVs cannot impede access for emergency vehicles.

For Single Family Residence owners: An unoccupied RV may be parked for the camping season. When a parked RV is occupied, occupancy is limited to a maximum of 14 days per named calendar month.

Note: Any unused days within a named calendar month may not be accrued, saved, nor transferred to other property owner(s) nor other property(s) owned by the same owner.

For a House Under Construction: One occupied or unoccupied RV during the camping season may be on a lot as long as active construction is diligently pursued.

It is the property owner's responsibility to keep a record of the number of days of 2nd RV, residential occupied RV or construction site RV usage. This registration is subject to review by Arrowhead Outreach so it is important for the days to be counted accurately and recorded on the calendar below.

In the event Arrowhead Outreach finds there is a discrepancy between the days marked on the calendar by the property owner and the actual days of qualifying RV usage, they will bring this discrepancy to the attention of the Board of Directors who will determine if further action in upholding the January 18, 2020 adopted RV Regulation is required. Note: This form may be amended and resubmitted as necessary at any time during the 2026 Camping Season.
