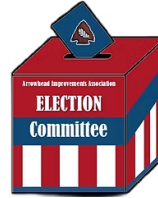
Purpose: Oversee and conduct elections of Board members or other elections in which property owners vote.

If this designation is already on file, and no changes have been made, it is not necessary to resubmit annually.

2025 BOD Election

- The AIA Board of Directors has engaged Law of the Rockies of Gunnison to receive ballots and tabulate the results.
- Ballots for the 2025 election will be mailed Thursday, October 9th, and **must be returned by mail, postmarked no later than Tuesday, November 25th, 2025.**
- Property owners' dues and/or assessments and/or fines must be current by September 30th, 2025, to receive a ballot. If you have moved or changed addresses, please make sure the AIA office has a current address on file.
